(2) "Competitive Business(es)" include any firm, partnership, joint venture, corporation and/or any other entity and/or person, _____ and/or any licensee of such entity, that develops, manufactures, markets, distributes, and/or sells any of the products described in Section 2.a.(1).

(3) Your "Job Duties" are those duties described in Exhibit A, attached hereto, as well as those duties as may from time-to-time reasonably be prescribed by the Company during the period of your employment with the Company.

(4) "Customers" means any firm, partnership, corporation and/or any other entity and/or person that purchased or purchases from the Company any of the products described in Section 2.a.(1).

(5) "Customer Prospects" means any firm, partnership, corporation and/or any other entity and/or person reasonably expected by the Company to purchase from the Company any of the products described in Section 2.a.(1).

(6) "Vendors" means any individual and/or entity that provides goods and services to the Company.

MEMORANDUM OF AGREEMENT

This Memorandum of Agreement made and executed between:

De La Salle University - Dasmariñas, a non-stock, non-profit educational institution, duly organized and existing under Philippine Laws with office/business address at Dasmariñas, Cavite 4115 represented herein by _____, Dean, College of _____, hereinafter referred to as the **UNIVERSITY**.

and

_____, a domestic corporation duly organized and existing under Philippine Laws with office/business address at _____, represented herein by _____, hereinafter referred to as the **COMPANY**.

Witnesseth:

The parties hereby bind themselves to undertake a Memorandum of Agreement for the purpose of supporting the UNIVERSITY'S on-the-job training for student-trainees under the following terms and conditions:

1. The UNIVERSITY shall be responsible for briefing the on-the-job student-trainees who intend to conduct practicum exposure in the COMPANY as part of the UNIVERSITY'S curriculum;

and Vice President of the Exchange Foundation (SEF), led Taiwan as a delegation of 13 members while Zheng Lizhong, Vice President of the Association of Relations between the Taiwan Strait (Arats), represented the interests of China. [13]
Subsequent rounds of ECFA lectures took place on 31st of 2010's tides in Taipei and 13th of June 2010 in Beijing. [13][14]
The final agreement was signed during the 5th round of self-arats speaks in 29 of June 2010 in Chongqing. Chiang Pin-kung, the president of the Taiwan SEF, represented Taiwan. Chen Yunlin, President of Arats, represented mainland China. [11][18]
The Taiwan executive Yuan approved the ECFA in the 2nd July of 2010 [19] and the legislative Yuan (Parliament) approved the agreement in 17 August, which means that the agreement became the law in January 11th of 2011. [20]
ECFA came into force on September 12th of 2010. [21][22]
Questions Debate Main Article: ECFA debate there is currently a lot of discussion © rsia in on ECFA, including on potential effects on local Taiwanese companies, [23], as well as on how the government has for the public. The Democratic Progressive Opposition Party (DPP) and other major groups believe that the ECFA is © a cover for the union with China© through an inextricable link between the two economies. It does not grant the same rights as a free© trade agreement that will reduce employment in industry© and the mastery, nor will it accelerate the flow© of capital and the flight of management and technology records. Opponents of the ECFA also expressed concerns about the possibility of the influx of white©-collar workers or mainland Chinese professionals working in Taiwan, which could jeopardize the employment security of the sites. [25]
According to Jie Huang of The China Review, Â© is a means of maintaining peace in relations between the two sides and "finally reach the goal of reunified". [7]
A debate was held and broadcast on April 25, 2010. Reference proposals blocked by the main article of the Ma administration: referendums in Taiwan in 2010, The Commission© of Anāilise of the Referent Pan-Blue-Camp originally controlled by China has several times rejected proposals for a referendum against the economic agreement of the administration of Ma Ying-jeou with the China[26][27][28][28][29] up to © the number of petition sums for a referendum was reached and nearly 200,000 signatures have been collected. [30][31][32][33]
The public opinion © opinion shows that the majority of respondents oppose signing this package with China and many experts and pollsters among the protesters consider a referendum to this effect essential. [34][35][36]
Demonstrators on the streets Tens of thousands of people turned to the streets to protest the signature of the ECFA that would boost the two©way trade organized by the Sunflower Student Movement, a popular movement that had general support but was not led by the Democratic Progressive Party of Taiwan's opposition. [37]
A DPP spokesperson said that the trade agreement with the will damage the local economy and undermine Taiwan's sovereignty as it was against one China's market concept. [38]
President Ma Ma replied that the subscription would not lead to a single market in China. [39]
Many protesters fear that the agreement will eventually lead Taiwan to unification with mainland China. [40]
The protest originally estimated a 100,000-person appearance. [41]
The DPP said that 100,000 participated in the protest, while the police said there were 32,000 people. [37]
The demonstration started at 3pm and was fired by 7pm. [38]
Confirm the Legislature in the 8th of July of 2010, a legislative meeting of Yuan was held. The DPP insisted on the ECFA agreement revised article by article. This demand was rejected by CMT Caucus. [42]
A six-minute flight later began between legislators. Wang Jin-Pyng was on the floor surrounded by other KMT legislators. Liu Chien-Kuo, Su Chen-Ching (UK) and Kuo Wen-Chen tried to reach him and failed. Lawmakers threw paper, water and garbage at each other. KMT legislator Wu Yu-Sheng was hit in the head by a relay. He had to be transported to the National Taiwan University Hospital. [42][43]
Several other people were involved in the fight. Two KMT legislators made DPP president Tsai ing-wen responsible for the shock. [42]
2020 Cancellation spectacular in June 2020, the Chinese state hand mentioned that it may terminate the agreement after triggering the withdrawal notice of 180 days, [44] although this does not happen. A Taipei Times editorial called the ECFA "a weapon in the Beijing arsenal to impoverish Taiwan". [45]
