



However, if the duration of the rental agreement is more than 12 months or 11 months, there is no requirement to register the agreement. In such a case, drafting and signing the agreement on the stamp paper will be valid as per law. In case the agreement duration is within 12 months, the rental agreement needs to be printed on a stamp paper obtained from the Sub-Registrar office of the place where the property is situated. The sample rental agreement that needs to be printed on the stamp paper can be downloaded by clicking the ¢ÃÂÂDownload¢Ã button provided at the top of this page. After the rental agreement is printed on the stamp paper must be signed at the bottom by both the owner and tenant. Two witnesses must also sign the agreement along with their names and addresses to make the agreement valid. In case the agreement duration is 12 months or more, the rental agreement needs to be printed on stamp paper and it needs to be registered with the Sub-Registrar¢ÃÂÂs office to execute the agreement. They must sign at the bottom of each page of the stamp paper on which the agreement is printed in the presence of the Registrar. Two witnesses must also sign the stamp paper and it should be registered after paying the required fees.
