HOW TO CLOSE a PLDT ACCOUNT? Again, in this iSensey PLDT guide, we are sharing the disconnection or closing procedure and requirements for a PLDT landline + HOMEDSL plan. First, identify if your PLDT plan is regular speed or hi-speed. Ours was a Home DSL high-speed plan at 1,699 monthly fee, 5 MBPs unlimited. What's the significance if regular plan versus hi-speed plan when it comes to account disconnection? If yours is a regular plan, in most likelihood you were charged a fee for the modem at the start of your PLDT plan subscription, therefore you don't have to return it. If the plan is a hi-speed plan like ours, we were required to return the modem, splitter, and modem adaptor, because we did not pay for the modem upon installation and activation of the landline and dsl internet service. Failure to return the modem + splitter + adaptor will incur a charge of P1,200. \*If you paid for the modem whether DSL or Fibr, you don't have to return it upon account termination. If you didn't pay for it, you need to return it. Second, identify if your PLDT contract has ended or if it's still ongoing. PLDT subscription plans usually carries a 24-months or a 36-months contract. Account closing BEFORE the contract period ends will incur pre-termination fee ON TOP of the fee for the number of days used within the current billing period, plus any overdue amount. If the contract ended, then you will only be charged for the usage until closing of account. iSensey experience: The 24-months lock-in period for our landline + Unlimited DSL plan ended two years ago, therefore, when we closed the account, we did not pay any pre-termination pay. We also don't have any overdue payment from previous months, so in the end we only paid for the 10 days usage covering the start of the current billing period to the day we closed the account. We think PLDT reps need to report the reasons why an account holder terminates his or her account, hence, the letter. You can write the letter on the spot at their office. For reasons, you can just write something like "I am closing my PLDT account because internet service in our area is terrible." Or "I am closing this account because I am transferring residence and wants to start a fresh contract there." etc. Sixth, pay in cash for the usage in the current billing period and any overdue amount. Keep the receipt for your file. The telephone and internet service will be disconnected on the same day of successful account closing. Can I just run away from my PLDT bill since I will transfer residence and they won't know my next address? Not advisable, don't do it. If you do, it'll be bad record against your name and you might not be allowed to open a new PLDT account in the future. Plus, remember that things are now connected and hi-tech; there is also a credit bureau in the Philippines, any bad record even for just a few hundreds or thousands for an unpaid telecom bill might cause you loan / credit card disapprovals and the like in the future PLDT account properly, it's easy to do!
